GENERAL INFORMATION:

- 1. All games will be 20 minutes semi-stop time (on free throws) and full-stop time during the last 15 seconds of the 1st half and last 2 minutes of the 2nd half.
- 2. There will be a 30 second shot clock for regulation (on request) and all overtime(s).
- 3. Timeouts: 4 Full Timeouts (no carry-overs).
- 4. Overtime: 1st overtime: 2 minute stop time. 2nd overtime: sudden death (Shot clock is in effect.) One timeout per OT.
- 5. Ball may be advanced to half court on timeouts during only the last TWO minutes of the game.
- 6. Free throw entry will be on release of the basketball.
- 7. Teams are responsible for their own insurance coverage.
- 8. Roster limit is 12 players, but only 10 long sleeve t-shirts are awarded to the 1st place winners. All participants will also receive a complimentary tournament t-shirt (10 max per team).
- 9. Roster and entry fee deadline is Saturday, September 28, 2014. All roster changes must be made prior to the registration deadline.
- 10. All game regulations are governed by High School rules.
